DIRECTIONS: From Route 15 (Merritt Pkwy/Wilbur Cross Pkwy): Take exit 56 from north or south. Turn right onto Route 121 (Grassy Hill Rd). Travel 1-1/2 miles, turn left onto Clark Lane. Entrance is on left. **From Interstate 95 (Connecticut Turnpike):** Take exit 39A. Heading north, turn right onto Route 1 (Boston Post Rd). Heading south, exit 39A merges into Route 1 (Boston Post Rd). Stay to the right. At the 3rd traffic light after Friendly's Restaurant, turn right onto Route 121 (North St). Travel 2-1/2 miles, turn right onto Clark Lane. Entrance is on left. **From Route 8:** Take exit 15. Turn right off ramp, go to 2nd traffic light, and turn right onto Route 34 (Derby Ave/New Haven Ave). Travel 2 miles, turn right onto Route 121 (Grassy Hill Rd). Travel 3 miles, turn left onto Clark Lane. Entrance is on left.

PROGRAM: The following Meritorious Service Awards will be presented: (1) Sgt. Mark Soneson, Officer Scott Calderone and Officer Michael Silverio of Berlin Police Department will be recognized for their involvement in resolving a very serious domestic dispute in March, 2012, that led to an exchange of gunfire. The suspect has since received a 45-year sentence resulting from this situation. (2) Off-duty Officer David Olszewski of Guilford Police Department, who observed a bank robbery in progress and reported it to Middletown Police Department, who apprehended the perpetrators upon leaving the bank on January 27, 2014. (3) Norwalk Police Officer Joseph Martino was dispatched in December 2013 to a report of a suicidal female. Upon arrival, he found a woman with a 357 revolver, disarmed her and no doubt saved his own life, the life of other officers and the suspect had she decided to quickly turn the gun on herself.
